La Folie is a considered a historical site by the government of France, the Climat de Bourgogne and the town of Vougeot. The property is governed by a set of protections designed to safeguard and maintain the integrity of the property and the surrounding vineyards, the history and reputation of La Folie and, most importantly, that help to provide a safe environment for any Guest or visitor. All Guests and visitors to La Folie must agree in writing to these protections as part of any booking request.

La Folie is located in an active vineyard, and also contains important historical pieces through-out the property, and as such, the following Protections must be read, agreed to, and adhered to during any use of La Folie by all Guests and visitors.

La Folie Protections

All Guests and visitors agree to abide by the following Protections and any violation of these Protections may subject the Guest and any visitors to immediate eviction from La Folie and forfeiture of their booked use and their paid fees, and prevention of any future use of La Folie.

1. It is strictly forbidden to stand or sit on the tower wall or to stand on the seating area due to the danger of a fatal fall or damage to the wall. No items can be dropped from the tower.
2. It is strictly forbidden for more than four people to be at the top of the tower at any one time due to the danger of a fatal fall from the tower or in the staircase.
3. It is strictly forbidden for any Guest or visitor to walk amongst the vineyards of the Clos Vougeot or those properties that are adjacent to La Folie.
4. All Guests are required to follow the town of Vougeot parking rules and must park their vehicle outside of the Clos de Vougeot. Parking in the Clos de Vougeot or at La Folie will result in the immediate forfeiture of the use of La Folie and the removal of the offending vehicle(s) at the expense of its registered owner/driver.
5. No items in La Folie are permitted to be removed – these include but are not limited to all usage items such as bath and shower products, toiletries, towels, bath-robos, hairdryers, hangers, pillows, mini-bar items, umbrellas, ashtrays, as well as all artworks, sculptures, decorative pieces, silverware, tableware, glassware, etc... The welcome gift is for the Guest who has booked La Folie and the consumable items are for onsite use only, as we adhere to a refill and reuse program as part of our environmental policy. All other items are not to be removed. Any removed items will be charged to the booking Guest at our replacement cost.
6. The booking Guest shall pay for any loss or damage to any La Folie property, whether caused by themselves or their visitors, during their booked usage. The booking Guest's caterer is permitted to move items associated with their use into La Folie and will remove all of these items by the conclusion of their utilization period. Any items left by the caterer will be disposed of and the associated fees

for disposal will be charged to and paid by the booking Guest. The Caterer is not to remove La Folie kitchenware.

7. The booking Guest is responsible for ensuring that the number of visitors and their arrival and departure are only as described in the below Daily Utilization Table – the Tower, especially, should not be utilized after dark due to risks to Guests and visitors. The event times and Guest arrival and departure times as described in the Daily Utilization Table must be adhered to, in order to allow for proper cleaning and preparation for future Guests.
8. Smoking is NOT permitted in any area within the La Folie building.
9. The booking Guest and visitors are fully responsible for any personal items that are lost, stolen, or damaged at La Folie.
10. Children, dogs (except for seeing-eye dogs) and other pets or animals are not permitted in the Clos de Vougeot or on the La Folie premises.
11. All Guests and visitors are required to follow the local/regional governmental recommendations for Covid or any other viral/contagion prevention.
12. All Guests and visitors utilize La Folie at their own risk and individual well-being and safety are the responsibility of the booking Guest of La Folie. By signing below you accept full responsibility for all non-negligent liability related to you or your visitors.
